<u>Technical Requirements & Specifications for Software Application</u>

Software Application shall contain the following basic features:

- 1. Development, testing, and deployment of web-based software solution for a government project.
- 2. Solution preferably on open-source technology.
- 3. The application should be able to link with existing applications under Kerala Government.
- 4. The work flow includes,
 - a. Registration using Name, Age, Address, Mobile no, etc.
 - b. Registration can be done by self or through AKSHAYA.
 - c. Unique number/ ld should be generated for each registered file and this number should be communicated through SMS, E-mail, etc.
 - d. An acknowledgement receipt shall also be generated.
 - e. Searching facility with the unique number/ id should be available in the application.
 - f. After registration, the file should flow based on a file flow/ work flow system through different levels of government departments before approval/closing.
 - g. Barcode generation and printing in the registered file.
 - h. File status should be updated to user via SMS / E-mail.
 - i. The web-pages should support Malayalam and English fonts.
 - j. Provision for image capturing while registration.
- 5. Deployment of qualified and experienced personnel for the above tasks.
- **6.** End-User training and Installations.
- 7. Database backup and restore.
- **8.** MIS and Reports.
- 9. Legacy data capturing (scanning/Data entry) facility.
